

**PARTY 96.3 – “TREAT YOUR BOOS SPIKED SELTZER BRACKET CHALLENGE”
SWEEPSTAKES**

Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. Eligibility:** The PARTY 96.3 – “Treat Your Boos Spiked Seltzer Bracket Challenge” Sweepstakes (the "Sweepstakes") is open only to individuals who are 21 years or and residents of Florida and who reside within 150 miles of Hubbard Radio West Palm Beach’s studio located at 701 Northpoint Parkway, Suite 500, West Palm Beach, FL 33407, to be eligible to win. No purchase necessary to enter the Sweepstakes. Employees of Hubbard Radio West Palm Beach, LLC and its radio station PARTY 96.3, (the "Sponsor"), Hubbard Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Sweepstakes Period:** The Sweepstakes begins at or about 8:00 AM Eastern Time (“ET”) on September 14, 2020 and ends at 11:59:59 PM ET on October 25, 2020 (the "Sweepstakes Period").
- 3. How to Enter:** To enter via the online method of entry, visit <https://www.party963.com> (“Website”) and find the Contest tab during the Sweepstakes Period to find, complete and submit the online entry form, which includes voting for your favorite spiked seltzer brand from the list on the Website (“Vote”), to receive one (1) entry into the Sweepstakes. Limit one (1) Vote per person per day. Voting is once (1) per day. Spiked Seltzer Brands will be displayed each week during the Sweepstakes Period. The spiked seltzer with the most Votes will advance to the next round the following week.
- 4. Random Drawing:** One (1) Grand Prize winner will be selected via a random drawing to be conducted by Sponsor on or about October 26, 2020, from among all eligible online entries received during the entire Sweepstakes Period. Decisions of Sponsor are final and binding. Odds of being the Grand Prize winner via the online method of entry depend on the number of eligible entries that are received during the

entire Sweepstakes Period. The potential Grand Prize winner will be notified by Sponsor via email or telephone on or about the day of the random drawing. Failure to respond to the winner notification within **two (2) days** will be deemed forfeiture of the Grand Prize and an alternate winner may be selected at Sponsor's sole discretion, time permitting. Sponsor is not responsible for email message notifications that are undeliverable or not received, or voicemail messages not received.

5. **Prizes and Approximate Retail Values ("ARV's") - One (1) Grand Prizes** – Ten (10) Rapids Water Park tickets. ARV: \$619.99. Tickets expire on November 28, 2020. Tickets are subject to the terms, conditions and restrictions printed on the tickets. Any tickets that are not redeemed by November 28, 2020 will be forfeited. Transportation and parking are not included as part of the prize. Prize is not redeemable for cash. Prizes are not transferrable and non-assignable and may not be substituted by Winner. Sponsor may substitute the prize or portion thereof for one of equal or greater value at Sponsor's sole discretion.

The Grand Prize winner must meet the eligibility requirements as set forth in Paragraph 1 of these Official Rules. 7. **Participation Conditions/Release/Consent to use Likeness:** By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees)

arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. 9. **Limitations of Liability:** The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited, to malfunctions, interruptions or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the participation process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of phone calls; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.
